#### **OVERVIEW OF COUNTY-WIDE ISSUES**

#### **Early Voting Has Begun**

Early voting has begun, and there's no time like the present to lock in your choices for this year's election.



Like many, in the past, I preferred to wait until Election Day to vote. I realized, however, that it could only take an unplanned event or the weather, to cause me to miss that opportunity. I decided to sign up and receive my ballot through early voting. I then deliver the sealed ballot to the Registrar's office so that I know my vote counted.

Another benefit of voting early: once you cast your ballot, campaigns usually stop targeting you with phone calls, texts and mail since they know you've already voted. This means fewer interruptions for you and allows candidates to reduce costs and focutheir outreach on those who haven't yet voted.

Please get out and vote for your candidates. District 1 voters can use the Registrar's office location at Victory Plaza on Mooretown Rd. (Home Depot location).

### **Curbside Recycling**

As many of you are aware, curbside recycling service has temporarily ended on September 30th. This follows a decision by the Virginia Peninsula Public Service Authority (VPPSA) Board of Directors to terminate its contract with Tidewater Fibre Corporation (TFC). Full details on what this means for recycling subscribers, as well as alternative recycling options, are available on the County's recycling portal.

Those of you in District 1, please note that JCC recycling locations are accepting items from York County residents while we search for an alternative recycling firm.

- Tewning Road Convenience Center at 117 Tewning Rd, Williamsburg
- Toano Convenience Center at 147 Industrial Blvd, Toano

#### Why now?

TFC was under contract to meet specific performance and material-handling requirements. Unfortunately, in recent months they consistently failed to meet those standards, including accurate weight recording and billing. Despite opportunities to correct the issues, the problems became frequent and significant enough that VPPSA determined it was in the community's best interest to end the contract immediately rather than continue service under those conditions.

#### What's next?

While it would have been ideal to have a new vendor in place before ending the current contract, the severity of the problems required swift action. VPPSA is moving quickly to identify and contract with a new curbside recycling provider, and I am hopeful service will resume in the near future.

Fords Colony located within JCC have recently opted for a new recycling firm for their HOA, so this is one of the options being considered.

#### **DISTRICT 1 SPECIFIC ISSUES**

#### Queens Lake Dam, Spillway and Lake Funding

I continue to pursue funding for the Queens Lake Dam and Spillway repairs to prevent environmental damage to Queens Lake estuary and a major loss of property values for residents of Queens Lake, as well as potential damage downstream. I spoke with Congressman Wittman recently. He is still pursuing discussion and negotiations with Doug Burgum, Dept. of Interior Secretary

The County has also checked recently with Army Corps of Engineering regarding the federal CAP grant for remediation efforts towards Queens Lake. The grant request letter issued by York County was submitted June 4, 2025.

A request for bid was issued to approximately 10 contractors for the Queens Lake stream restoration project. The contract was issued to Howard Brothers Contractor, Inc. A pre-construction meeting will be held in the next few weeks between Public Works and the contractor.

#### Fenton Mill Update

I reported last month that the Fenton Mill Development project had received an Emergency Stop Work Order in response to a number of environmental violations at the construction site.

The issues have been resolved, and the Stop Work Order lifted. County staff met with the construction sub-contractor (LaRS Group Inc.) and the Developer (Forestar Group) to set a clear path forward and agree upon necessary conditions to allow work to continue.

Recent heavy rains have not resulted in flooding of the adjacent neighborhood; however, sediment carry-over to Carters Creek has been observed. The situation continues to be closely monitored.

Waller Mill Heights has also been issued an Emergency Stop Work order recently, ensuring that the County's standards on environmental protection are maintained throughout construction.
